

"Our customized ConcourseSuite platform enables owners and CEOs to have that command and control. We have a clear and concise communications channel between the owner, CEO and management, which enables us to keep everyone on the same road. building a business. ConcourseSuite provides that."

Chairman's View has developed a dashboard application, which can be used to measure performance within the business and was built using ConcourseSuite's standards-based plug-in architecture. "The chairman can monitor business performance in real time," says Richards. "There are three aspects to that: revenue generation, which is forward looking; delivery, which tracks how well the company is meeting the sales promises it has already made and how much capacity is available;

In addition to utilizing ConcourseSuite to manage and deliver its own services, through the course of its engagements, Chairman's View uncovers client needs that can also be remedied by using ConcourseSuite.

One circumstance involves a mid-sized distribution firm in Connecticut. This company hired Chairman's View to assess its revenue pipeline, delivery system, management structure and financial organization; make recommendations based on those findings; and help with their execution.

The initial engagement uncovered several weaknesses within the company that ConcourseSuite could easily help solve. At the highest level, core activities relating to sales, customer service and delivery were mismanaged, not for a lack of talent, but because the company did not possess the tools and processes needed to properly operate and grow. ConcourseSuite provided key capabilities including:

and finance, which looks at the current financial position. This insight enables the chairman to have control of the business, so he or she can implement the vision that has been agreed to."

The dashboard has been developed using industry standard JSR-168 portlets. The latest release of ConcourseSuite includes a complete Portal/Portlet engine which allows any Java-savvy developer to develop custom applications that can be run and viewed natively from within ConcourseSuite. The interface is seamless for users. Portlets can combine data from within ConcourseSuite with data from legacy systems. "I don't know of anyone else who provides that level of flexibility at that price," says Richards.

ConcourseSuite is available under an open source license. "We knew at the outset that we needed an open source platform," says Richards.

"There are a number of advantages with open source. The software is more stable because there are more people working on it. It's not like dealing with a company where the code is theirs and theirs alone, which can make it difficult to make any changes. We can develop our custom pieces much more quickly using ConcourseSuite."

Richards was previously chairman of a software company for five years and conducted an extensive market evaluation before choosing ConcourseSuite as the platform to build upon. "Compared to other CRM vendors, we were impressed by the quality of the company, code and people at Concursive" he says. "The people at Concursive have been extremely flexible in their dealings with us. They understand our needs, and the team has been building world class software for seven years. ConcourseSuite has been highly ranked by inde-

pendent magazines, and our customers have the option to upgrade into all the additional functionality that ConcourseSuite provides."

Chairman's View builds business processes around ConcourseSuite which dramatically increase business value. "When you can lock down processes, companies become extraordinarily valuable," says Richards. "It proves they are well run and can be transferred. The value creation in using ConcourseSuite is tremendous."

Because ConcourseSuite provides an enterprise class security infrastructure, businesses are able to extend access to their trusted advisors. Chairman's View's clients can allow accountants and investors to access profit and loss totals, for example, while their attorneys can have access to everything. This transparency is also valuable for demonstrating the value of the business. Richards cites the example of one of his clients which approached its bank for a loan. "The bank wanted proof of the company's growth, so the chairman went into ConcourseSuite and provided the answers there and then," he says. "Within minutes, the bank had its own access to the dashboard through ConcourseSuite. It blew them away. They could get all the reports they needed automatically. Using ConcourseSuite, capital partners can see that it's a buttoned down company and can agree to a better deal more quickly."

As well as installing ConcourseSuite in client businesses, Chairman's View uses it to manage its own affairs. "Our regional chairs can see who's approached which customer, and can track our opportunities," says Richards. "ConcourseSuite is elegantly simple. Everyone is wowed by how we are able to run our business, and because we use the right tool in the right way, we're able to scale. If we didn't have ConcourseSuite, we'd need an extra three staff just to control the business and it would mushroom from there as we grew. Using ConcourseSuite, if we want to open a new office, we can do it tomorrow."
